Release, Waiver, Indemnification, Hold Harmless, and Assumption of the Risk Agreement:

Whereas, in return for privileges in the Massasoit Gun Club, Inc. (hereafter "MGC") and use of premises, the undersigned agrees to the following:

The undersigned agrees to indemnify, hold harmless and defend the MGC, and any of its employees, directors, officers, or agents from any and all fault, liabilities, costs, expenses, claims, demands, or lawsuits arising out of, related to or connected with: the discharge of firearms; the Undersigned's participation in any club activities; the range, buildings, land and premises used for the sporting activities (hereinafter "Premises"); the undersigned's presence on or use of said premises; and any and all acts or omissions of the undersigned. And should any such claim, demand or lawsuit arise or be asserted in any way whatsoever related thereto, whether arising under the laws of the United States or of any state, or under any theory of law or equity, the undersigned will indemnify, hold harmless, and defend the MGC, from any and all costs, expenses, or liability including, but not limited to, the cost of any settlement or judgement made or rendered against the MGC, whether individually, jointly, or in so lido with the undersigned, together with all costs of court and other costs or expenses incurred in connection with any such claim, demand, or lawsuit, including attorney's fees. The undersigned furthermore waives for himself/herself and his/her executors, administrators, assignees, or heirs, any and all rights and claims for damages, losses, demands, and any other actions whatsoever, which he/she may have or which may arise against the MGC, (including, but not limited to any and all injuries, damages, or illness suffered by the undersigned or the undersigned's property), which may, in any way whatsoever, rise out of, be related to, be connected with: the premises, including any latent defect in the premises; the undersigned's presence on or use of said premises; the undersigned's property (whether or not entrusted to the MGC); and, the discharge of firearms. The MGC shall not be liable for, and the undersigned, on behalf of himself/ herself and his/her executors, administrators, assignees, or heir, hereby expressly releases the MGC from any and all such claims. The undersigned hereby expressly assumes the risk of entering the premises and of taking part in activities on the premises, which include, but are not limited to, instruction and the use of firearms, the discharge of firearms, and the firing of live ammunition. The undersigned furthermore hereby acknowledges and agrees that he/she has read, understands, and will at all times abide by all MGC range rules and procedures. This instrument binds the undersigned and his/her executors, administrators, assignees, or heirs.
